



**ABSTRACT**

A combination of descriptive and analytical research design is used in this study. There were seventy (70) respondents of the study. Interview, questionnaire, books and internet were used as research instrument and the data gathered were computed and interpreted with the use of statistical tool such weighted mean and likert scale.
